ORDINANCE NO. 1332-17

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION OF CITY COUNCIL FOR CITY COUNCIL PLACE 1, CITY COUNCIL PLACE 3, AND CITY COUNCIL PLACE 5, HELD SATURDAY, MAY 6, 2017.

WHEREAS, the General Election of 2017 was held in the City of Richland Hills, Texas on the 6TH day of May 2017, for the purpose of electing persons to the positions of City Council Places 1, 3, and 5, as provided by the City Charter; and

WHEREAS, it is hereby found and determined that notice of the election was duly given in the form, manner and time required by law, and said election was in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings governing the holding of such elections; and
